



# Braunstone Community Primary School

*Be the best version of you!*

At Braunstone Community Primary School, all children and colleagues **'Belong'**. To further enhance belonging it has been agreed by all stakeholders (parents, school, Advisory Board, and Trust) that a whole school uniform demonstrates this. We believe a uniform allows all pupils, regardless of background, to feel equal to their peers and confident in their appearance. Our uniform policy has been designed to be inclusive for all children, practical and conducive to a successful learning environment. We encourage our children to wear their uniform with **pride** and to make every effort to look **smart**.

Braunstone Community Primary School is committed to ensuring equality and value for money, and that no pupil is discriminated against due to their religion or belief, economic circumstances, or social and cultural background – this policy contains provisions to meet these objectives. We have selected items that are readily available at supermarkets as a **cost-effective** alternative that are perfectly suitable.

Our children are expected to be well presented. Whenever school uniform is worn, it should be complete. Parents or carers of children who have been sent to school not wearing the appropriate uniform maybe asked why and offered an alternative from the schools' 'swap shop' supply, however this is a limited collection of items.

All clothing and footwear should be clearly **labelled** with the child's name. This may be with a sewed in name tag or written clearly in a visible position with a permanent pen.

On special occasions, the school may announce a non-uniform day where children can wear their own clothes that are appropriate to the activities that are happening on that day.

## **Our uniform includes:**

- Navy-blue jumper, sweatshirt, fleece, or cardigan.
- White polo t-shirt.
- Grey or black school trousers.
- Grey or black school skirts.
- Grey or black school shorts (near to knee length).
- Plain black, sensible shoes –but plain black trainers are also acceptable.
- A waterproof, weather appropriate coat.
- White or navy hijab (headscarf).
- White or navy patka.
- Navy book bag or backpack.
- One plain, stud earring per ear but must be removed by the child for PE or swimming.
- Refillable water bottle.
- Navy and white gingham summer dress.
- Long hair (below shoulder length) must be tied back with a simple hair scrunchy or bobble.

**P.E. Kit:**

On the day that your child has PE, the children should **arrive** in school dressed in their PE kit. These items are encouraged due to their ease of wear for physical activities:

- Navy/Black PE shorts.
- White t-shirt.
- Trainers.
- Or any suitable clothing for physical activity (no jeans).
- Earrings must be removed by the child.
- If children are not suitably clothed and an alternative cannot be offered, then they may not participate in the P.E. lessons due to health and safety concerns.

**Swimming:**

- A suitable swimming costume or appropriate length swimming shorts (with inner lining) or trunks.
- Swimming hats are recommended but not essential.
- Long hair (below shoulder length) must be tied up.
- Towel.
- Long shorts or bikinis are **not** permitted.
- Earrings must be removed by the child.
- Goggles can be worn if a letter of approval from parent or guardian is submitted, staff are not allowed to assist in the wearing/placement of goggles.

**Sun Protection:**

Please ensure your child is adequately protected by:

- Applying sun cream to your child before they leave for school.
- Providing a bottle of sun cream (if you wish to), clearly named with your child's name. This will be kept in your child's classroom, and they can apply it. Please note staff are NOT allowed to apply sun cream.
- Making sure your child has a sun hat.

**These items (although not exhaustive) are not permitted:**

- Make up. If your child arrives in school wearing makeup, they will be asked to remove it with water.
- Nail varnish or gel nails.
- False nails, including acrylic nails.
- Any form of jewellery (unless it is for cultural, religious or medical reasons) apart from one earring stud per ear. If your child does arrive in school wearing jewellery, they will be asked to remove it and it will then be placed in a named envelope at reception to be collected by an adult.
- High heels.
- Flip flops or strappy sandals.
- 'UGG' boots or boots like these.
- Jeans.
- Short, shorts (shorts should be near to knee length)
- Belly tops/crop tops.
- Strappy tops.
- Large hair accessories – bows, elaborate hair ties.
- Leggings (unless for PE).
- Hoodies.
- Items of clothing that display inappropriate images or words.

## **Legislative framework**

This policy has due regard to statutory legislation and national guidance, including, but not limited to the following:

## **Religious clothing:**

- Some religions and beliefs require their members to conform to a specific dress code. Braunstone Community Primary School does not discriminate against any religion or belief; however, the school must weigh the needs and rights of individual pupils against the cohesion and health and safety concerns of the entire school community.
- The school endeavours to allow most religious requirements to be met.

## **Cost and availability:**

- Under the School Admissions Code 2014, the school must ensure that “policies around school uniform or school trips do not discourage parents from applying for a place for their child”.
- Braunstone Community Primary School is committed to fulfilling the DfE’s recommendations on costs and value for money.
- Every care has been taken to ensure that our uniforms are affordable for all current and potential pupils, and that the best value for money is secured through reputable suppliers.
- Braunstone Community Primary School has ensured that all items of clothing can be obtained through major supermarkets and clothing stores.
- All Pupil Premium children receive two free jumpers at the start of the academic year.
- The school do not enter exclusive single supplier contracts or cash-back arrangements.
- The school do not amend uniform requirements regularly and considers the views of parents/carers and pupils when considering changes to school uniforms.

## **Equality:**

- The schools are required to ensure that the Uniform Policy does not discriminate unlawfully.
- Every step has been taken by Braunstone Community Primary School to ensure that the cost of children’s uniforms is not disproportionate based on gender.

## **Non-compliance**

- If the uniform policy is breached, the class teacher will speak to parents or phone home and ask the parent to provide the child with the appropriate uniform.
- If a parent is contacted by the class teacher on three or more occasions, this will then be passed onto the child’s phase leader. The phase leader will contact the parent to see what support is needed and this will be recorded.

- School will keep a limited selection of spare uniform for the child to change into if the uniform breach cannot be rectified. This uniform will be returned at the end of the school day rather than the child going home in it.
- In cases where a child is wearing clothing that is inappropriate for health and safety reasons, parents or carers will be asked to take their child home to get them changed.
